State Rep. Robin Shackleford announces run for mayor of Indianapolis

State Rep. Robin Shackleford announced her intention to run for mayor of Indianapolis.

Shackleford and her campaign team held a press conference Nov. 10 in the lobby of the Madam Walker Legacy Center to announce her plans to enter the race for mayor for the 2023 election.

Shackleford, a Democrat who is

SCOTUS seems unlikely to side with Marion County agency questioning civil rights precedent

The U.S. Supreme Courtheard oral arguments Nov. 9 for a case that involves an Indiana nursing home and a Marion County public health agency. The case has captured national attention due to its far-reaching implications for federal safety net programs across the country.

The arguments addressed two questions: Do people on federal assistance programs like Medicaid have the right to sue states in federal court if their rights are violated? And do nursing home residents have the right to bring civil rights lawsuits against government-owned nursing facilities? A ruling in favor of



the Health and Hospital Corporation of Marion County could strip millions of people who rely on federal assistance programs, including Medicaid, of the right to sue government agencies when they do not receive benefits allowed by federal law.

After oral arguments, some legal experts say the Supreme Court seems unlikely to undo decades of legal precedent that establishes the right of Medicaid recipients to sue states. The court appears, however, to be more receptive to a narrower argument: that nursing home residents in government facilities may not have the same right to sue states in federal court.

Many legal experts say the

civil rights law known as Section 1983 grants private citizens the right to sue government agencies and officials if they violate their constitutional rights.

But HHC, which owns more than 70 nursing homes across Indiana, argues that the right to sue does not extend to nursing home residents and people who rely on federal assistance programs.

Thomas Fisher, the Indiana solicitor general, argued in support of HHC. He said the cases lower courts use to evaluate whether a federal law establishes an enforceable right have been confusing for states and courts.

In reply, Chief Justice John Roberts said the legal prec-

EXPLAINER: Where does the student loan debt plan stand?

President Joe Biden's plan to provide millions of borrowers with up to \$20,000 apiece in federal student-loan forgiveness has been blocked by a second federal court, leaving millions of borrowers to wonder if they'll get debt relief at all.

On Nov. 10, U.S. District Judge Mark Pittman ruled that the program usurped Congress' power to make laws. The administration immediately filed a notice to appeal.

It's not the only challenge the plan faces. Last month, the 8th U.S. Circuit Court of Appeals in St. Louis put loan forgiveness on temporary hold while it considers a challenge from six Republican-led states.

The fate of the plan will likely eventually end up in the Supreme Court, meaning a final decision is a ways off.

Here's where things stand:

HOW THE FORGIVENESS PLAN WORKS

The debt forgiveness plan announced in August would cancel \$10,000 in student loan debt for those making less than \$125,000 or households with less than \$250,000 in income. Pell Grant recipients, who typically demonstrate more financial need, would get an additional \$10,000 in debt forgiven.

The White House said 26 million people have applied for debt relief, and 16 million



and the

people had already had their relief approved.

THE TEXAS CASE

Pittman — an appointee of former President Donald Trump based in Fort Worth, Texas — made it clear that he felt Biden overstepped his authority. He said the Higher Education Relief Opportunities for Students Act of 2003, commonly known as the HEROES Act, did not provide the authorization for the loan forgiveness program.

The law allows the secretary of education to waive or modify terms of federal student loans in times of war or national emergency. The administration said the CO-VID-19 pandemic created a national emergency.

But Pittman said such a massive program required clear congressional authorization.

THE PLAN FACES MANY OTHER LEGAL

CHALLENGES

In September, the Republican-led states of Nebraska, Iowa, Kansas, Missouri, Arkansas and South Carolina filed suit to halt the program, arguing that the pandemic no longer qualifies as a national emergency. Justice Department attorney Brian Netter disagreed, telling U.S. District Judge Henry Autrey in October that student loan defaults have skyrocketed over the past 2 1/2 years.

Autrey ruled on Oct. 20 that the states lacked standing, allowing the forgiveness plan to proceed. But the 8th Circuit temporarily halted it the next day while it considers a permanent block. That decision is still pending.

The White House encouraged borrowers to continue applying for relief, saying the court order did not prevent applications or the review of applications.

The plan has faced other legal challenges. In October,

Supreme Court Justice Amy Coney Barrett rejected an appeal from a Wisconsin taxpayers group. A federal judge had earlier dismissed the group's lawsuit, finding they didn't have the legal right, or standing, to bring the case.

THE TEXAS RULING WAS A BIGGER BLOW TO THE PLAN

Pittman's decision strikes down the underlying legal argument used to justify Biden's plan. Previously, the White House has been able to dodge legal attacks made in lawsuits by tweaking details of the program.

One lawsuit argued that the automatic debt cancellation would leave borrowers paying heavier taxes in states that impose a tax on canceled debt. The administration responded by allowing borrowers to opt out. Another suit alleged that Biden's plan would hurt financial institutions that earn revenue on certain kinds of federal student loans. The White House responded by carving those loans out of the plan.

The new ruling, however, argues that the HEROES Act does not grant authority for mass debt cancellation. The law grants the Education Department wide flexibility during national emergencies, but the judge ruled that it's unclear whether debt cancellation was a necessary response to COVID-19, noting that Biden recently declared the pandemic over.

SUPREME COURT-BOUND?

The legal situation is complicated because of the numerous lawsuits. It's likely that the Texas case and the lawsuit filed by the six states will be appealed to the Supreme Court. Before it reaches that level, the 5th and 8th Circuit appeals courts — both dominated by conservative judges — will rule separately in each case.

The case before the 8th Circuit could end up in the Supreme Court soon, since the six Republican-led states have asked the appeals court to keep the program on hold while the case plays out. If the appeals court grants that request, the administration will likely ask the Supreme Court to intervene. The states also could go to the high court if their request is denied.

Likewise, the administration has signaled it will appeal the Texas ruling. If the 5th U.S. Circuit Court of Appeals is asked to block Pittman's ruling pending appeal, the losing side could then turn to the Supreme Court.

'Half American: The Epic Story of African Americans Fighting World War II at Home and Abroad' by Matthew F. Delmont

Raise your hand. If something's going to get done around here, you're volunteering because things need to be different and you're ready and willing to make it happen. This starts with you because, well, who else? As in the new book "Half American" by Matthew F. Delmont, there'll be no more doing things halfway.

In the time before America entered World War II. Black Americans kept their eyes on what was happening overseas, particularly in Spain. The rise of fascism during the Spanish Civil War was of particular interest to them because "fascism was Jim Crow with a foreign accent." Eighty Black Americans even volunteered to fight against the Nationalists.

Their efforts caught the attention of writer Langston Hughes, who was hired by a

Black-owned newspaper to follow the American soldiers and report about it. While in Spain, he described the "realities of war," but he also noticed something that astounded him: "in this anti-fascist army," Hughes wrote, "Negroes and whites marched, trained, and fought together."

Benjamin O. Davis graduated from West Point in 1936, and had his sights set on a career in the military. Davis, says Delmont, "desperately wanted to be a pilot" but such opportunities weren't then available to a Black

man, no matter what his accomplishments. Davis and other Black U.S. soldiers had to battle racism within the ranks first.

Pullman union leader A. Philip Randolph organized a march on Washington for the rights of soldiers and homefront workers. Thurgood Marshall, chief lawyer for the NAACP, became "energized" by his work for equality, particularly that of Black Americans who wanted to volunteer to "serve their country without being degraded by their countrymen."

But, says Delmont, that "was only half the fight. Victory would be incomplete unless it also uprooted white supremacy. ... These dual war aims coalesced under a slogan that came to define the **Black American experience** during the war: Double V."

No matter how much you think you

know a subject, there are always stories you're missing. On the topics of racism and war, "Half American" will tell you some tales.

This is one of those books that fills in the blanks on the things you missed in history class — or the things you were never told in the first place. The stories in here are stunning and quite moving, but also frustrating, even 90 years after the fact. It's like sitting at the VFW, listening to old war stories that were told in a whisper but that need shouting.

Author Matthew F. Delmont, who is a history professor at Dartmouth College, explains that his research and this story as a whole "has forced me to see the war with fresh eyes."

Readers, whether veterans or not, should agree.

Beware that this book can occasionally seem a bit academic – it's heavy with dates and site names, but the feeling passes quickly enough that armchair historians can still enjoy it greatly. If you need to know more about Black history in World War II, find "Half American" and raise your hand.

currently chair of the Indiana Black Legislative Caucus, would make history as Indianapolis' first Black and first woman mayor if elected.

Shackleford's mayoral campaign will focus on seven main areas: economic growth, public safety and transportation, affordable and equitable housing, decreasing the achievement gap in schools, mental and physical health care, eradicating food deserts and promoting inclusivity.

"As I weighed my decision to run, fueled by close friends and family, some asked me why I was even considering it," Shackleford said at the press conference. "It came down to one phrase that kept running through my head: We can do better."

Shackleford first addressed the disparities in Indianapolis, calling it a "tale of two cities." Some residents feel safe, drive on good roads and don't worry about putting food on the table, Shackleford said. However, others drive on pothole-ridden streets, struggle to provide and fear that any moment "a stray bullet will travel through their wall and strike their child."

"We simply cannot have a prosper-

ous Indianapolis unless it is uniformly safe," she said. "I commit to providing effective solutions and prioritizing the safety of Indianapolis and its residents — in all neighborhoods."

Indianapolis, Shackleford said, needs a mayor that will both challenge and support business leaders, commit to creating better jobs, dedicate to helping minorities, women and veteranowned businesses, and champion Indianapolis as a destination for growing businesses.

Without affordable housing, Shackleford said Indianapolis would not be able to achieve an adequate economy supported by its workforce. Shackleford said she will work to increase affordability and equity in housing as well as develop a plan to encourage development without displacement.

"No one should be afraid of losing their home because their neighborhood is being developed," she said. "We can do better."

Shackleford said she would also "advocate relentlessly for better roads, sidewalks and transportation connectivity" by closing the billion-dollar infrastructure funding gap and ensuring federal transportation funds are distributed efficiently and equitably.

"We are tired of driving on battered, pothole-ridden streets," she said. "And we cannot fathom seeing another one of our children hit by a vehicle due to the lack of sidewalks in their neighborhood."

Health care disparities have been especially apparent during the pandemic, and Shackleford said access to health care is crucial for keeping Indianapolis residents healthy and safe. However, she said health care isn't just about the body, but also the mind.

Shackleford said she would work to not only improve access to quality and affordable health care for seniors and working families but also help address chronic health conditions such as mental illnesses.

"We cannot afford to have another person suffering from mental illness slain like Herman Whitfield III," she said, citing the man who was killed in April in police custody after an apparent mental health crisis.

Shackleford said she will hold listening sessions for youth to engage them in the decisions being made that affect them as well as to teach them how to advocate for themselves.

She said she would also work toward job opportunities that would connect students to their professional interests while they're in school and will fight for public schools "so we may advocate for a better tomorrow."

"Tomorrow must be equitable for all," she said. "We can harness the boundless potential of all the incredible people of our great city to turn challenges into opportunities — just like Madam Walker did. These are not easy problems to tackle, but together we can elevate our city to new heights."

Shackleford was first elected to the Indiana House of Representatives in 2012 and represents the 98th District on Indianapolis' east side. She also serves as board president for Pathway Resource Center.

Richardson said in a phone interview. "And quite honestly, I'd say, 'I just did it.' It was just instilled in me to be strong."

Growing up in New York, Richardson said that kind of mindset strength and courage was something that had to be learned early on, especially for young men of color like himself.

"I had to learn how to be strong at that time, and really push through people actually literally hating us just because of what they thought that we committed these crimes," he said. "So it was definitely challenging during the '80s and '90s, to overcome this obstacle."

Now, Richardson dedicates his time to being a social justice activist, advocating for criminal justice reform and fighting for those who have

Project — a nonprofit organization that works to free the innocent, prevent wrongful convictions and create fair, compassionate and equitable systems of justice for everyone, according to its website.

"We've always been close and sharing the same common bone as others that don't have the privilege to be heard or seen," he said. "I use my platform to raise awareness and bring the light to injustices that are still happening amongst people of color, of course, but it's happening to women and children, it's happening everywhere." Richardson said he would participate in a fireside chat-style discussion at the library on Nov. 18 and give a keynote speech followed by a Q&A during Fall Fest on Nov. 19. Rather than talking about his experience with wrongful conviction — a story many are already familiar with — Richardson said his talk would focus said. "Because at that time, nobody thought that we — the five of us — would even arrive from that situation, so we always say 'life after death."

One thing Richardson said he hopes to encourage in others is to keep pushing forward. With two daughters of his own, he said hope drives him to keep going and be that inspiration for others. Richardson said. "Even in the darkest times when I was going from precinct to precinct and paparazzi were taking pictures and flashing in my face, my mother always said, 'Keep your head up because you didn't do anything wrong."

In addition to Richardson's talk, the festival will include a poetry contest, rappers and spoken word artists ranging from grads 6-12 and performances from winning entries to this year's Slammin' Rhymes Challenge.

Indianapolis Breakdancer Pep-C, Headbangers Kickboxing Academy, Deckademics DJ School and Natural Measures Trampoline Super Sessions will also give performances in addition to a poetry reading from Eric Saunders, the Green Eyed Bandit. "Local students need an opportunity and a venue to express themselves by sharing their written words," Cordia Watkins, event organizer and circulation manager at the Indianapolis Public Library, said in a statement. "With this presentation, they get a chance to be heard by the public which can assist with teaching them the art and fundamentals of oral speaking, presentation, and reading skills while building their confidence and character."

edent regarding which laws give rise to rights under Section 1983 are clear and impose a "pretty high bar in terms of the evidence that was required."

Roberts asked: "Why isn't that sufficient?"

Some legal experts told WFYI that Roberts' skepticism of the Marion County agency's argument was among the most telling moments during the oral arguments because Roberts represents a crucial swing vote that could ultimately decide the case — or at least its first question of whether Medicaid beneficiaries have the right to sue government agencies.

An attorney representing HHC and the Indiana solicitor general argued that because Section 1983 was enacted by Congress in the 19th century, it could not have been intended to give third parties the right to sue to enforce a government contract. At that time, the attorneys said, common law for contracts did not confer that right.

Justice Ketanji Brown Jackson countered, saying Congress enacted Section 1983 specifically as a vehicle for everyday people to be able to sue states and government officials who violate federal law and their civil rights. Jackson said it seems "odd to suggest that we as a court can reinterpret the word 'law' in Section 1983 to carve anything out."

Justice Amy Coney Barrett also joined Brown's questioning of HHC's lawyers' arguments and said she cannot see "the connecting of the dots."

While the justices seemed unlikely to limit the right of people on federal assistance programs to sue, some justices appeared receptive to arguments questioning whether that right extends to nursing home residents.

Benjamin W. Snyder, assistant to the U.S. solicitor general, argued that at the time the Federal Nursing Home Reform Act was adopted by Congress in 1987, nearly 90% of nursing homes in the U.S. were privately owned.

He said that it seems Congress believed other remedial and enforcement mechanisms, such as administrative procedures, were sufficient for those nursing home residents without the need for recourse from federal courts. "Congress contemplated providing a private cause of action against those private parties, but left that out of the ultimate bill it enacted," Snyder said. Justice Brett Kavanaugh responded,

"That's an unusual line to draw on. [It] would be a new line in the case law. That's not to say it's not a good line here. But it would be different."

Unlike in most of the country, government agencies own the vast majority of the nursing facilities in Indiana, as well as Pennsylvania. Justice Sonia Sotomayor questioned why the court should assume that Congress wanted to take away the right of residents at these facilities to use Section 1983 "as an additional remedy for a violation of a state obligation."

A decision on the case could come as late as June 2023, the end of the court's term.

Paul Garcia, a partner in the regulatory department of national law firm Hooper, Lundy & Bookman in California, has been following the case. He said many legal experts and patient advocates seem to be breathing a cautious sigh of relief after the oral arguments.

"I thought ... the real question before the court was, are they going to issue a normal decision? Or are they going to drop another bomb like the Dobbs decision" that resulted in the overturn of Roe v. Wade, Garcia said. "My takeaway was, the court seems reluctant to drop another bomb."

But Ben Geffen, senior attorney at the Public Interest Law Center in Pennsylvania, said a decision not in favor of nursing home residents may be likely. Such a decision could make it harder for people in governmentowned nursing homes to enforce their rights.

"I guess the silver lining is that a result like that probably would be restricted to Indiana and Pennsylvania, because as a practical matter, those are the two states where this is currently how it's run," Geffen said.

Downtown Indy receives \$3.5M for safety, cleanliness and outreach

The city of Indianapolis will partner with Downtown Indy Inc. to invest about \$3.5 million into safety, cleanliness and outreach downtown.

"Downtown Indy belongs to and serves our entire city as an economic engine, as a hub for arts and culture and as a seat for local and state government," City-County Council President Vop Osili said at a press conference Nov. 10.

With this investment there are plans to add increased overtime for Indianapolis Metropolitan Police Department bike patrol and three mobile security cameras to IMPD monitoring software. There will also be an opportunity in early 2023 for small businesses to participate in a grant program targeted to gain participation in IMPD's b.link camera system, which connects IMPD with security camera systems owned by residents and businesses.

Cleanliness investments include maintenance and regular cleaning in downtown alleys, sidewalks and other areas. According to a press release, Downtown Indy Inc. plans to expand its existing efforts to assist homeless residents by working with service providers to hire more social workers and housing navigators focused on the downtown population.

The partnership is a response to the impact of COVID-19 and will last 18 months. Major events coming to downtown Indianapolis in that period include the 2024 NBA All-Star Game, USA Swimming 2024 Olympic Trials and Big Ten championship games.

"Indianapolis is at its best when partners come together to make our community safe and welcoming for residents and visitors." said Rick Fuson, CEO of Pacers Sports and Entertainment, in a press release. "These investments will help accelerate Downtown's continued transformation and cement its place as a destination for families, residents and visitors during all seasons."

Election Day saw few major problems, despite new voting laws

WASHINGTON (AP) — Heading into this year's midterms, voting rights groups were concerned that restrictions in Republican-leaning states triggered by false claims surrounding the 2020 election might jeopardize access to the ballot box for many voters.

Those worries did not appear to come true. There have been no widespread reports of voters being turned away at the polls, and turnout, while down from the last midterm cycle four years ago, appeared robust in Georgia, a state with hotly competitive contests for governor and U.S. Senate.

The lack of broad disenfranchisement isn't necessarily a sign that everyone who wanted to vote could; there's no good way to tell why certain voters didn't cast a ballot.

Voter advocacy groups promoted voter education campaigns and modified voting strategies as a way to reduce confusion and get as many voters to cast a ballot as possible.

"We in the voting rights community in Texas were fearing the worst," said Anthony Gutierrez, director of Common Cause Texas. "For the most part, it didn't happen."

False claims that the 2020 election was stolen from former President Donald Trump undermined public confidence in elections and prompted Republican officials to pass new voting laws. The restrictions included tougher ID requirements for mail voting, shortening the period for applying for and returning a mailed ballot, and limiting early voting days and access to ballot drop boxes.

There is no evidence there was widespread fraud or other wrongdoing in

the 2020 election.


An estimated 33 restrictive voting laws in 20 states were in effect for this year's midterms, according to the Brennan Center for Justice. The most high-profile and sweeping laws were passed in Georgia, Florida, Iowa and Texas. Arizona also passed new voting rules, but those were largely put on hold this year or will take effect later.

Of the four states with major voting law changes in effect, a preliminary analysis shows a decline in turnout among registered voters in Florida, Iowa and Texas, while Georgia turnout declined slightly. Several factors can affect turnout, including voter enthusiasm and bad weather.


In Texas, the bumbling rollout of new voting restrictions in the state's March primary resulted in officials throwing out nearly 23,000 mailed ballots as confused voters struggled to navigate new ID requirements.

But preliminary reports after election Nov. 8 showed rejection rates reverting to closer to more normal levels, which election officials attributed to outreach and mail voters figuring out the new rules. In San Antonio, county officials put the preliminary rejection rate at less than 2% — a sharp reversal from the 23% of mailed ballots they threw out in March.

The problem with Kanye

The headline implies that Kanye West — who legally changed his name to "Ye" - has just one problem. In point of fact, he has myriad problems. (Jay-Z infamously confessed that he had 99; Ye has eclipsed that number.) And there are myriad reasons why all people should have

problems with West.

Ye's virtuosity as a rapper and producer is, rightfully, the stuff of legend. While the term "genius" is often applied capriciously, one could argue that the appellation is fitting for him. Unfortunately, Ye has devolved into a troubled, perhaps mentally ill pied piper of abject ignorance. Further, his antisemitic statements have caused him to become a foil for neo-Nazis, some of whom recently cited him while desecrating a Jewish cemetery.

Importantly, this is not simply about Ye. Given his celebrity, Ye's behavior has had the inevitable effect of impairing other Black folks' credibility in criticizing those who engage in anti-Black racism. It also impacts those of us who offer legitimate criticisms concerning discrimination (e.g., speaking out against Israel's treatment of Palestinians). The sad reality in America is that the bad actions of one Black person. especially a famous one, reverberate to the detriment of the rest of us.

Still, legions of Black folks cling to Ye with unashamed obstinacy. His outsized platform is a vessel for their pent-up frustrations in large part because

most of us exist at or near the margins of a society that is still infected by racism. Even though Ye's actions have caused him to lose his billionaire status, he is still viewed as a wealthy and powerful Black man who defies all efforts to "cancel" him. But the sycophantic deification that has attached to him is misplaced. Such reverence should be reserved for those who actually act to advance the interests of African Americans.

Speaking of which, I ask the following in all sincerity: What has Ye ever done to benefit Black folks as a people? Has he given seed money to dozens or hundreds of Black businesses? Has he donated millions to Black charities? Has he championed voting rights or criminal justice reform? (His ex-wife did the latter.) The answer to all those questions is a resounding "no."

In fact, Ye has done the opposite. He goes on anti-Black tirades that border on self-abnegation. Predictably, his actions are applauded and amplified by conservative whites. That fits a pattern. Consider, for example, the reception that talking heads Candace Owens and Jason Whitlock receive from their adoring, Trump-loving fans. Conservative whites' version of DEI is supporting Black people who don't like Black people.

I can understand why some African Americans are able to compartmentalize Ye's artistic output from his political posturing. However, I simply cannot fathom how any of us actively embrace this iteration of the artist formally known as "Yeezy."

Then there is the issue of West's mental state. On the one hand, if he is mentally ill, we should take

that into account when assessing his behavior. On the other hand, we run the risk of giving him a "pass." I'm not a mental health professional. Even if I were, there is a taboo about diagnosing someone who isn't under one's care. Thus, I'll leave it at this: I don't know whether West's actions are the result of a genuine mental illness or "marketing" or sincerely held beliefs. He either has a sick mind or a sick heart Either way, his actions damage us — as Black people and as a nation.

Finally, it is extremely disturbing that Black people who consistently trash other Black people aren't ever "canceled" — unless their Black victims are members of other marginalized groups (e.g., LGBTQ+). Why don't Ye's advertisers and business partners care about his vitriol against George Floyd's family? Why don't sponsors and record companies drop Black artists who glorify murdering other Black people? The answer is that too few people — including us care about Black people dehumanizing other Black people.

In 2005, Ye infamously declared on national television, "George Bush doesn't care about Black people." While I never voted for Mr. Bush, there is scant evidence that West's claim was true. Tragically, there is ample evidence that Ye is actually the one who doesn't care about Black people.

According to the Center for Information & Research on Civic Learning and Engagement (CIR-CLE), an estimated 27% of youth (18-29) cast a ballot in the 2022 midterms - the second-highest youth turnout in the last three decades. Moreover, CIRCLE reports that the youth turnout was even higher in some battleground states.

If you're not a stats type of person, then let's look at Florida for a real-life example. Maxwell Alejandro Frost, 25, will become the first Gen Z member of Congress. He beat his Republican opponent by 20 points. Rep. Val Demings held this seat but ran for U.S. Senate against Sen. Marco Rubio and lost.

Here in Indianapolis, many from the millennial and Gen Z generations are hungry to serve their communities and represent the issues that matter to their neighbors. They serve on boards, work in executive positions, are entrepreneurs, are appointees on Indianapolis boards and commissions, serve at the grassroots level as a precinct committeeperson, are elected officials on township boards and more! They know the issues and want to take them on. These generations have fresh ideas to improve our city; all they want is a shot.

To my young people (including myself), we are here! As cliche as it sounds, we are making our voices heard! You may say, LaMar, I don't want to serve as an elected official, but I want to engage in the political process. So let me share some ideas with

infrastructure funding, a three-year anti-violence plan and safeguarding local politics from the partisanship of state and federal government.

Mostly, though, Hogsett talked about unfinished business. It wasn't long after he was reelected in 2019 that focus had to shift to the COVID-19 pandemic, and despite saying in 2015 he would step down after two terms, he said during his announcement he's focused on "things left undone."

"We are going to finish what we have started," Hogsett told supporters.

That includes funding for anti-violence programs and establishing a clinician-led crisis response team, something the city plans to pilot in early 2023, along with development plans throughout downtown.

Hogsett's announcement sets up a showdown with Shackleford, who is chair of the Indiana Black Legislative Caucus and has been a state legislator since 2012, representing District 98 on Indianapolis' east side.

In a statement, Shackleford said she welcomes the "exchange of ideas" over the coming months leading up to the primary election in May 2023.

"As I said when I announced my candidacy," Shackleford said, "I am running for mayor because I am the right person to address the issues facing Indianapolis that have not been solved in the past eight years - issues such as tackling root causes of crime; creating a world class workforce; prioritizing diversity,

equity and inclusion; and increasing transportation connectivity and infrastructure."

Marion County Republican Central Committee Chairman Joe Elsener used Shackleford's campaign announcement to take a jab at Hogsett, who emphasized multiple times that his third term would be his last. "Even Democrat Rep. Robin Shackleford described Joe Hogsett's Indianapolis as a city with '...pothole-ridden streets where residents struggle to get enough to eat and worry that at any moment a stray bullet will travel through their wall and strike their child," he said in a statement.

In his quest for a third term, Hogsett will also have to contend with the fact that Shackleford would be the first Black and woman mayor of Indianapolis. Hogsett attended a private fundraiser after the campaign event and did not take questions from media. Hogsett used a significant portion of his time


at the podium to talk about the challenge the city faces with crime and violence. His approved 2023 budget will allocate a little more than \$300 million to public safety agencies and programs. Still, Indianapolis continues to regularly set new homicide records, with 249 murders in 2022, which surpassed the previous record of 214 murders in 2020.

But Hogsett said he wasn't announcing his candidacy to talk about the past.

"All I can see as I stand here tonight is tomorrow," he said to applause.

It isn't clear if others will also seek the Democratic nomination. City-County Council President Vop Osili is thought to be an eventual candidate for mayor. Osili couldn't be reached for comment after Hogsett's announcement.

Intend Indiana unveils new homes as part of HomePower initiative

Intend Indiana is trying to bring new life to Martindale-Brightwood neighborhoods through its affordable housing HomePower initiative.

Serving communities in Indianapolis and surrounding regions, Intend Indiana is a nonprofit that works toward expanding community development by providing affordable housing and small business development.

Stephanie Quick, chief operations officer of Intend Indiana, said the organization rebranded in January of 2020 when Renew Indianapolis and King Park Development Corporation partnered. She said the organization now prioritizes its four main initiatives to better serve the Indianapolis neighborhoods.

One of these initiatives is Renew Landbank, which aids in returning vacant, abandoned or distressed properties into usable spaces. Affordable HomeMATTERS is another initiative that focuses on homeownership as well as preserving and developing inclusive, diverse and equitable homeownership opportunities.

The other two initiatives are the Build Fund and Edge Fund. Build Fund focuses on small business lending and connecting local businesses to affordable financing, while Edge Fund provides flexible financing and promotes inclusive and diverse housing opportunities.

Intend Indiana recently received a \$126,600 grant from the Indianapolis African American Quality of Life Initiative (IAAQLI) to fund its HomePower program, which is pairing homebuyers in Martindale-Brightwood with five rehabbed homes and 12 new-build homes, Quick said.

The five rehabbed homes were sold for an average of \$131,000, Denise Herd, a spokesperson for Intend Indi-

ana, said in an email.

"The real estate market has been very robust, and for a low- to moderateincome buyer to enter into that real estate market, it's very challenging," Quick said. "We try to add to that affordable inventory as well as create that pipeline of low- to moderateincome buyers who have an interest in living in the Martindale-Brightwood area so that they may have a first opportunity — or a first look, so to speak — at affordable homeownership opportunities."

On Nov. 3, Intend Indiana unveiled four of the HomePower program's new construction homes in the Martindale-Brightwood area. Each of the homes are three bedrooms, two baths and approximately 1,500 square feet.

Quick said the Cummins Foundation provided up to \$90,000 toward the overall sale price of the homes. She said this caps the sale price of the homes at \$240,000 — which is based on construction costs — bringing down the buyer's first mortgage to \$150,000. Quick said the \$90,000 is then

included with the property as a "silent second," with zero percent interest and zero payments so long as the homebuyer remains in the home for a period of 10 years. She said it's called the 10-year affordability period.

Doris Baringer, a substitute special education teacher with Indianapolis Public Schools, was the first person to move into one of the newly built HomePower homes. Having rented in a neighborhood she wasn't comfortable in for three years, Barringer said she desperately wanted a place to call her own again — the only issue was she couldn't afford a down payment.

"Life's up and down with divorce and all of that, so I had to rent for a few years and, you know, I always wanted to own my own home again," Barringer said. "I didn't know if I would be able to do it, but you just keep praying."

However, after reading an article about Cummins Foundation's donation

for the HomePower program in the Martindale-Brightwood area, Barringer said she called the next day to see if the program was actually doing what it claimed.

Within a few days, Barringer completed the application process, qualifying her for the program. Two weeks later, she completed all the necessary steps, passed financing and was looking at houses. Barringer closed on her home Aug. 19 and moved in Aug. 20.

"They were willing to work with me outside of maybe the norm of what most people do, go online, do this and that," she said. "They made it easy because they told me what I need."

Barringer said she had been close to giving up on her dream of being a homeowner, but now has a place she can grow old, plant flowers and paint the walls without consequence.

A remaining nine of the 12 Home-Power houses have homebuyers lined up to move in by the end of this year and early next year, Quick said. She said they're working to secure purchase agreements for the remaining three homes.

A majority of the homebuyers go through Intend Indiana's Homeownership 101 classes, Quick said. The classes provide education on financial preparation on buying homes and teach necessary tools for maintaining a home for first-time homeowners, she said.

Intend has held a total of five Homeownership 101 classes in 2022, and Herd said it plans to restart the program in February 2023.

Going forward, Quick said she hopes to continue Intend's HomePower program beyond the 12 homes as well as continuing to work toward comprehensive community development.

In brutal drought, Kenyan herders look for hope underground

ARCHERS POST, Kenya (AP) — Letoyie Leroshi walked for five days hunting water. After three years of drought in Samburu County, Kenya, the riverbeds were bone-dry.

Then Leroshi found a patch of wettish sand in the sunbaked Ewaso Ng'iro riverbed. He brought a group of fellow herders to dig. They hit water and the jubilant young men broke into song, a traditional call to their cattle and camels.

Harnessing Eastern Africa's groundwater could be a huge benefit for a region struggling to slake its thirst. Climate change is making drought more likely but, as in much of the continent, people in East Africa and the Horn of Africa lack the resources to tap groundwater on a wide and efficient scale.

For Leroshi and other Kenyan herders, the situation is desperate.

"We had thousands of livestock four years ago when we experienced short rains," he said. "We have lost hundreds of our cattle and are now worried that if the rains fail yet again, we will lose everything."

Leroshi and other herdsmen carry weapons and are prepared to fight if attacked by people trying to steal from them.

"Everyone else around is also armed and ready to steal our livestock," he said.

The British charity WaterAid and the British Geological Survey found that Africa has enough groundwater for most countries to get through at



least five years of drought. "Groundwater has great potential for drought resilience," said Girma Ebrahim, a hydrogeologist with the International Water Management Institute. The United Nations water agency estimates that roughly 400 million people across Africa lack access to clean water. Lmeshen Lekoomet, 54, recently left with the family's few remaining animals in search of pasture and water. As his family waited, his 2-year-old became severely dehydrated and malnourished and was hospitalized. Lekoomet never returned.

In the coastal cities of Dar es Salaam in Tanzania in 1997, and in Cape Town in South Africa in 2017, drought led people to use groundwater. In Ethiopia, wells equipped with handpumps outperformed all other sources during a drought in 2015 and 2016.

Africa has 72 giant aquifers that are largely untapped, scientists say. Some farming and pastoral communities in these regions already rely on wells, using digging by hand and with solar-powered equipment.

"This is a game-changer," said Edwin Macharia, the director of programs for the aid agency Mercy Corps in Ethiopia.

Other regions of the world provide cautionary tales of how the misuse of groundwater can make situations worse. "Not to say it should not be exploited," said Philip Wandera, former director of the Kenya Wildlife Service and now range-management lecturer at the Catholic University of Eastern Africa. But, he said, 'Groundwater is not a quick-fix answer for the current drought … if you have been poor

managers of surface water, it means you are likely to do the same with groundwater."

Only 3% of the total cultivated land in sub-Saharan Africa is irrigated land, according to the U.N. Only 5% of that land is irrigated with groundwater.

Groundwater exploration and construction are impossible without financing. Many countries outside Africa had enough money to create groundwater databases and hydrogeological maps in the 1980s.

"Smallholder farmers who make up most food producers on the continent," badly need irrigation technology, said Agnes Kalibata, who heads the Alliance for a Green Revolution in Africa.

The U.N. says that, despite concerns about groundwater, the continent's resources are largely unaffected by climate change.


"Millions of people don't have enough safe, clean water to meet their daily needs, let alone face the climate crisis," said Tim Wainwright the chief executive of WaterAid in the United Kingdom. "Governments, along with the private sector, should use COP27 to agree on investments in responsible groundwater use, along with clear management guidelines to harness it."

Those in Samburu can't wait much longer, with many herders on the brink of losing everything.

"I have lost 30 cows in a span of two weeks and if it continues like this we will lose many more. Our women and children are also severely affected," said 30-year-old herder Lemerwas Limayo. "Drought ravages all living things."

Thanksgiving dinner is one of the largest meals prepared by families each year and food poisoning is a serious public health threat.

According to the Centers for Disease Control and Prevention,

handwashing is especially important when handling raw meats to avoid spreading bacteria around the kitchen.

Hand washing should always include five simple steps:

I. Rinse hands with clean, running water, turn off the tap, and apply soap.

2. Rub hands together with soap, lathering the backs of hands, between fingers, and

under finger nails.

3. Scrub hands for at least 20 seconds.

4. Rinse hands well under clean, running water.

5. Dry hands using a clean towel.

Another recommended guideline is to not rinse or wash raw turkey. Doing so can spread bacteria around the kitchen, contaminating countertops, towels and other food. Washing poultry doesn't remove bacteria; only cooking the turkey to the correct internal temperature will do this.

Remember to wash hands before and after seasoning the turkey. Nearly half of the people in a recent USDA study contaminated their spice containers when seasoning poultry. When handling raw meat, wash hands completely before and after rubbing in the seasoning.

Cooking the turkey to the right temperature is critical. Take the meat's temperature with a food thermometer in three areas — the thickest part of the breast, the innermost part of the wing, and the innermost part of the thigh. All three locations should reach 165 degrees Fahrenheit.

If one of those locations does not register at this temperature, continue cooking until all three locations reach 165 degrees Fahrenheit. Stuffing cooked inside the turkey's cavity should also get checked with a food thermometer to make sure it reaches 165°F. Even though the turkey's breast, wing and thigh registers at the correct temperature, the stuffing temperature can lag behind because of its density. Turkeys are tricky enough, so it's easier to keep things simple and cook the stuffing outside the bird.

After the meal, people tend to graze on food throughout the day. When perishable food sits at room temperature, it can enter a temperature range where bacteria like to grow. This range, between 40-140 degrees Fahrenheit, is known as the 'danger zone.' If food sits in room temperature for more than two hours it should be thrown away.



Q&A with Rev. Dr. Angelique Walker–Smith, new president of World Council of Churches from North America

Rev. Dr. Angelique Walker-Smith, former executive director of the Church Federation of Greater Indianapolis, was elected president of the World Council of Churches from North America. She was one of eight presidents elected during the council's 11th assembly, which was held Aug. *3*1-Sept. 8 in Germany.

Walker-Smith, who identifies as Pan-African, was ordained at the Convent Avenue Baptist Church, a historic Black church in Harlem, New York. She received her bachelor's degree from Kent State University, her master's degree from Yale University's Divinity School and her doctorate degree from Princeton Theological Seminary. While in Indianapolis, she was a volunteer prison ministry chaplain for women at Indiana Women's Prison. Today she serves as the senior associate for Pan-African, orthodox and ecumenical faith engagement at Bread for the World in the U.S., an ecumenical representative for the National Baptist Convention USA and a columnist for the Indianapolis Recorder. respective regions. By virtue of the office, the presidents (presidium) are leaders of the WCC along with the moderator, vice-moderators and the general secretary in their roles of governance. Presidents are also members of the central committee. Presidents may be invited to moderate sessions of the central committee or assembly and may be invited to undertake certain tasks or reflections and report back to the central committee. The term of office of a president shall end at the end of the next assembly following his or her election.



In this Q&A, learn about Walker-Smith's new position and her ambitions as president.

HOW DOES IT FEEL TO BE THE NEW WCC PRESIDENT FROM NORTH AMERICA?

I am profoundly honored and humbled to be elected to this ministry responsibility. It's taking a while to get used to the idea and am still learning what it may mean. I am appreciative of the prayers and words of encouragement I have received since Sept. 5 when the WCC presidium was formally announced, elected by the hundreds of church delegates, prayed over and sent by them after commendation from the global nominating committee, our regional churches and ecumenical bodies and national church bodies.

This process commends a deep sense of accountability and listening to these leader as well as the laments and hopes of all of God's people and creation. This, while carefully discerning a way forward with them in this global, national and local season of challenges and new possibilities with and for all.

WHAT ARE YOUR RESPONSIBILITIES AS PRESIDENT?

I am one of eight elected World Council of Churches presidents by the delegates at the World Council of Churches 11th World Assembly. I was elected as the president from North America. There are eight presidents from Africa, Asia, Europe, Pacific, Latin America/Caribbean, North America, Eastern Orthodox and Oriental Orthodox. The basic premise of the role of president is that the person should be one whose ecumenical experience and standing is widely recognized by the member churches and among the ecumenical partners of the World Council of Churches in their respective regions and ecclesial traditions.

According to the WCC Constitution the primary role of the WCC presidents is to promote ecumenism and interpret the work of the WCC, especially in their fied in both countries in North America.

HOW LONG WILL YOU BE PRESIDENT? CAN YOU RUN MULTIPLE TERMS?

Each of the eight presidents serves immediately upon their election until the end of the next WCC Assembly. The next WCC Assembly is proposed for 2030; therefore service for up to eight years. WCC presidents do not run for office. They are each commended and nominated by their region's churches and regional ecumenical bodies to the WCC global nominating committee as stated above. Candidates that are commended and nominated present themselves before the delegates in their region upon invitation from them and a maximum of two names from the region are forwarded to the WCC global nominating committee for consideration for election by the delegates.

ARE YOU THE FIRST BLACK WOMAN ELECTED TO THIS POSITION?

I am the first woman of African descent in North America from the Historic Black Churches and Baptist confessional family in this elected role.

WHY DO YOU THINK YOUR ACCOMPLISHMENT IS IMPORTANT TO THE BLACK COMMUNITY?

I think it shows and exposes once again the resilience, resolve and hope of people of African descent, Africa and our Christian partners and allies. This new role comes on the shoulders and sacrifices of those who came before me. Some may say it is actually sad that only in 2022 this moment has come and not many years ago. The Bible teaches that all of us are made in the image of God (Imago Dei).

But our confession must speak to the truth that we have fallen short of receiving the beauty of all of our diverse gifts among diverse peoples and groups. Moments like this remind us of how far we have to go while also thanking God for the revelation of indicators like this that show us what is yet possible.

WHAT ARE SOME OF YOUR PLANS AND AMBITIONS MOVING FORWARD?

An open process, facilitated by our national councils in the USA and Canada, was used to determine the concerns in our North American regional meeting at the 11th assembly. Our concerns reflect a follow-up to the partnership with the engagement of the WCC Pilgrimage of Justice and Peace process that also complemented these existing issues identified in both countries in North America. Therefore, my presidential mandate is clear from the North American region and is consistent with the global ecumenical priorities. Our issues and concerns reflect our commitment to unity, mission and justice that come together in our region and globally. I am grateful for this clarity.

The first concern agreed upon is connected to racism, which divides all of us. We seek to address the wounds and lament resulting from this scourge and advocate for transformation that moves us to justice and reconciliation for and with all.


The second issue is not far behind the first: climate justice. This is a matter of urgency for and with all that disproportionately affects people affected by racism, white supremacy and white privilege.

The third is the generational wealth and income gap that is related to inequality, inequities, poverty and hunger. All of which beg the questions of how we promote human dignity, human rights and human flourishing that can lead to sustainable life expressed in the Sustainable Development Goals (SDGs) and abundant life God intends for all.

The fourth, also intersectional with the other three, is the reconciliation with Indigenous peoples and lands. Advocacy within our churches, communities and with our policy leaders is critical to addressing these issues not only in interpersonal and communal spaces but in changing systems and structures that promote these concern/issues.

FINALLY, WOULD YOU LIKE TO ADD ANYTHING YOU BELIEVE PEOPLE SHOULD KNOW ABOUT YOUR NEWLY ELECTED POSITION?

I would like to thank the people of greater Indianapolis and Indiana. I would especially like to thank those who served with me and supported me in the roles I served in, and much more, that were mentioned earlier. I thank you sincerely for what you did to encourage our ministry and mission work together to make a difference in the Hoosier state, our country and world. This still informs and inspires me now. To God be the glory and may God continue to bless and enrich your lives as we serve God and God's people.

Connecting folks and food: Pacers Minority Guest Chef program sparks opportunity

Pacers fans may have noticed their game day snacking options are expanding as a program for minority guest chefs called The Kitchen returned with a new lineup of local chefs for the 2022-23 season.

Originally launched last year by the Gainbridge Fieldhouse Food Co., The Kitchen brings in local Black and other minority chefs from around Indianapolis to cook and serve their specialty dishes to fans on select game days.

Jerry Purvis, vice president of hospitality strategy for Fieldhouse Food Co., said each of the guest chefs partner with Gainbridge for a select amount of games, undergoing a short mentorship with Gainbridge Fieldhouse Food Co. as they prepare to present their signature dishes on a larger scale at The Kitchen stand on the main concourse in Section 17.

For the 2022-23 season, the program is hosting three Black chefs: Tasha Claylor of TStreet Eatz, Kenneth Hardiman Jr. of Forked Up Catering and Phillip Guy of Guy's Cooking Creation.

Forked Up Catering, a veteran-owned and familyoperated catering business, got its start in 2018, Hardiman said. Although he's usually serving up a unique twist on homestyle Southern cuisine at festivals around Indiana, Hardiman said the guest chef program has been an opportunity to make people smile with his food - a fact made evident by the swarms of people flocking to his stand at a game earlier this month before the game had even started.

"The first game — to see people, you know, come back and say 'it was amazing,' — you know, one guy said he wanted to slap his mom," Hardiman said with a chuckle. "I was like, 'You might not want to do that.' But yeah, it's been an amazing experience."

Hardiman and his wife took over The Kitchen during the Nov. 4, 7 and 9 games featuring a menu of a signature chicken tikka taco, roasted cauliflower and chickpeas in coconut curry and shrimp and grits which Hardiman said included their signature secret sauce.

What's in the secret sauce?

"I can't tell ya," Hardiman laughed, but added that

the sauce is what takes the dish to "the next level." "I believe my specialty is just making sure that the

food is flavorful regardless of what I make," Hardiman said. "Some things are challenging, but at the end, it's all about having everyone smile if they get anything, then being affordable."

Last year, the guest chef program hosted six Black chefs and restaurant owners, including Terry Anthony of The Block Bistro & Grill, Monique and Kara Hawkins of Taste of Innova Wings + Greens and Chris Mitchell of Just Like Sunday.

Run by mother-daughter duo Monique and Kara Hawkins, Taste of Innova Wings + Greens first opened in June of 2021 at The Amp at 16 Tech as a way to bring their family together during the pandemic, but it was so successful at Gainbridge last season that they were invited back as a permanent feature at each of the games this season, Monique Hawkins, co-owner and co-founder, said.

"It's really been a gift because we can be a testament," Kara Hawkins said, "to what it looks like to be family, to work and continue the legacy with one another."

During games, both Hawkins – dressed in match-

ing black outfits and aprons donning their business name – are serving up their game day menu to Pacers fans on the Club Level fourth floor. That menu includes seasoned collard greens with smoked turkey, cauliflower, a specialty cocktail called "The Number 12" and three of their specialty wing flavors: Italian Parm, African Pepper Zest and Uncle Nearest Innova Chile — a whiskey-infused wing sauce that stemmed from a partnership with Uncle Nearest in June.

"That infused flavor came from one of the sauces I created during the chef program last year," Monique Hawkins said. "It built up such great demand, and I knew that if I had an opportunity to come here, they've already had that taste and will be seeking for this."

WASHINGTON (AP) — Prices at the wholesale level rose 8% in October from a year ago, the fourth straight decline and the latest sign that inflation pressures in the United States are easing from painfully high levels.

The annual figure is down from 8.4% in September. On a monthly basis, the government said Tuesday that its producer price index, which measures costs before they reach consumers, rose 0.2% in October from September. That was same as in the previous month, which was revised down from an initial reading of 0.4%.

The figures came in lower than economists expected and make it more likely that the Federal Reserve will increase its benchmark interest rate in smaller increments. It has hiked its short-term rate by three-quarters of a

meeting.

"The improvement in the October inflation data, if it persists, supports the Fed's expectation of a step down in the pace of increases going forward," said Rubeela Farooqi, chief U.S. economist at High Frequency Economics, a forecasting firm.

Most of the monthly increase reflected higher gas prices at the wholesale level, which rose 5.7% just in October. The cost of new cars fell 1.5%, last month, which could lead to lower prices at the retail level as well.

Excluding the volatile food and energy categories, core producer prices were unchanged in October from September, the lowest reading in nearly two years. Core prices increased 6.7% last month from a year ago, down from a 7.1% annual rate in September.

The report follows last week's betterknown consumer price index, which showed that year-over-year inflation cooled to a slower-than-expected 7.7% in October, down from 8.2% in September. And excluding volatile food and energy costs, that report also said that core prices rose just 0.3% in October from the previous month, half the increase of the previous two months.

Those consumer inflation figures sent stock markets soaring because they suggested that the devastating price spikes of the past 18 months might finally be moderating. The cost of used cars, clothing, and furniture fell, a sign that goods prices are reversing their big price leaps of last year,

ports have been cleared, the price of ocean shipping has tumbled and more stores are building larger stockpiles. All those trends suggest that goods prices could continue to decline.

EARTH AT 8 BILLION: Consumption not crowd is key to climate



warmed almost 0.9 degrees Celsius (1.6 degrees Fahrenheit) since the world hit the 4 billion mark in 1974.

Climate and population is a touchy subject for scientists and officials.

With more people consuming energy, mostly from the burning of fossil fuels, is warming the planet, the key issue isn't the number of people as much as how a small fraction of those people are causing way more than their share of carbon pollution, several climate and population experts told The Associated Press. "We do have a population problem and we do have a population issue," said Vanessa Perez-Cicera, director of the Global Economics Center at the World Resources Institute. "But I think most importantly, we have an overconsumption issue."

"One of the biggest arguments that I hear almost exclusively from men in high-income countries is that, 'Oh, it's just a population problem," The Nature Conservancy Chief Scientist Katharine Hayhoe said. "Nothing could be further from the truth."

"The 50% poorest people in the world are historically responsible for 7% of heat trapping gas emissions," Hayhoe said. "Yet when you look at which countries are bearing the brunt of the impacts from climate change, countries like Malawi, Mozambique, Senegal, Afghanistan topped the list."

And even within countries, it's the wealthiest who cause more of the carbon pollution, Hare said. Overall, he said, "80% of the population, the global population, emits a small fraction of emissions."

The world's population is growing mostly in sub-Saharan Africa and south Asia "and they're contributing the least to man-made climate change," said Colette Rose, project coordinator at the Berlin Institute for Population and Development. Eight nations, five in Africa, three in Asia, are going to have at least half of the population growth between now and 2050, Rose said. They are Egypt, Ethiopia, Tanzania, Nigeria, the Democratic Republic of Congo, Pakistan, India and the Philippines. Worldwide population growth has substantially slowed, will likely peak sometime this century and is now down to growing less than 1% a year, Rose said. But carbon emissions are growing faster, at 1% more this year than 2021. For environmental advocacy groups and officials the issue of population and climate has caused problems. "Population is an issue that no one has wanted to touch from the very beginning. Too politically sensitive," Joanna Depledge, a climate historian from the University of Cambridge in England, said in an email. "There are many dimensions, notably in relation to religion and accusations of racism - population growth is mostly concentrated in non-white populations, of course." For a long time, the Sierra Club had promoted efforts to try to control the world population, until a couple decades ago, when the environmental group looked harder at the issue and broke down the numbers, said the group's president, Ramon Cruz. They found the problems were more overconsumption and fossil fuel use and those problems would be the same "at 6 billion, 7 billion or 8 billion" people, he said. While most environmental groups try to avoid the issue, 11 years ago, when the world hit 7 billion people, the Center for Biological Diversity made special issue condoms with population and environmental messages such as "Wrap with care, save the polar bear."

And because of that the 8 billionth child born will "not have what we had ... because there's not enough resources," she said.

Kenva, which is suffering through a devastating drought, has 55 million people, about 95 times more than the population of Wyoming. But Wyoming emits 3.7 times the carbon dioxide as Kenya. Africa as whole has 16.7% of the world's population but historically emits only 3% of the global carbon pollution, while the United States has 4.5% of the planet's people but since 1959 has put out 21.5% of the heattrapping carbon dioxide.

The average Canadian, Saudi and Australian put out more than 10 times the carbon dioxide into the air though their daily living than the average Pakistani, where onethird of the nation was flooded in a climate change worsened event. And in Qatar the per capita emissions is 20 times Pakistan's, according to the World Bank.

"The question is not about population but rather about consumption patterns," said climate scientist Bill Hare of Climate Analytics. "So it's best to look at the major northern emitters to begin with."

Climate Interactive, a group of scientists who run intricate computer simulations that can be tweaked to see what factors matter the most in fighting climate change, looked at the difference population makes. It found it made a small contribution compared to other factors, like economics.

Comparing two United Nations population projections scenarios of 8.8 billion people and 10.4 billion people, Climate Interactive's Drew Jones found only a 0.2 degrees Celsius (0.4 degrees Fahrenheit) difference. But the difference between no price or tax on carbon and \$100 a ton was 0.7 degrees Celsius (1.3 degrees Fahrenheit).

Hare said there is more than a tinge of racism in the myth that overpopulation is the major issue behind climate change.

Beyoncé ties Grammy record after leading nominations with 9

LOS ANGELES (AP) -Beyoncé has propelled herself into the highest Grammy echelon: The star singer claimed a leading nine nominations Nov. 15, making her tied – with her husband Jay-Z — as the most nominated music act in the history of the awards show.

Beyoncé's "Break My Soul" reeled in record and song of the year nominations, while "Renaissance" — which ventured into the world of dancehall music — netted an album of the year nod. With Jay-Z also earning five nods this year, each spouse now holds the record for the most-ever Grammy nominations at 88 apiece.

Kendrick Lamar came away with the second-most nominations, with eight. Adele and Brandi Carlile both received seven nods. Harry Styles, Mary J. Blige, Future, DJ Khaled, The-Dream and mastering engineer Randy Merrill each picked up six.

Nearly half of this year's leading nominees - announced by the likes of Olivia Rodrigo, John Legend, Machine Gun Kelly and Smokey Robinson – are women and more than half are people of color, according to the recording academy. The ceremony will be held Feb. 5 in Los Angeles.

"This makes me feel very proud, but it makes me conscious of the fact that we have to maintain the work we have done," said Harvey Mason Jr., the Recording Academy's CEO. He said there have been strides in the peer-driven voting system and increased membership, but he still believes more progress can be made

"This year, I'm pleased with the result and work the voters did," he continued. "We have almost 13,000 voters now. It's really important work. I'm pleased to think they spent the time listening to the music and evaluating. I think you see by the type of nominations that they are not only going

Christina Aguilera's comeback to Latin music with her self-titled album earned her two nominations for best Latin pop album and immersive audio album.



Colts hope emotional win helps inspire 2nd half charge

INDIANAPOLIS (AP) - Indianapolis Colts interim coach Jeff Saturday understood the low expectations.

Nobody gave him, or his team, a chance. Saturday doesn't anticipate much changing this weekend with Philadelphia coming to Indy for his first home game as coach.

But after leaving Las Vegas with a win, the first-time NFL coach wasted no time delivering another message on the team flight home – emotions alone won't get the Colts into the playoffs. Only focused players and coaching can shed the label of underdog.

"Execution, to me, is doing exactly what we're coached to do, so that if we have to solve problems midgame, we understand where everybody was supposed to be so that we can make an adjustment," Saturday said less than 24 hours after logging a 25-20 victory in his coaching debut. "From an emotional perspective, to me, emotion usually runs out about midway through the first quarter."

Somehow, despite a third consecutive turbulent week in Indianapolis, Saturday pushed all the right buttons and the Colts responded with their most complete game all season.

They ran the ball effectively and created explosive plays on offense. Defensively, they held Josh Jacobs in check and finished with a flurry - game-saving pass breakups on the Raiders' final two plays. And together, they snapped a three-game losing streak, a feat few

thought possible amid the national debate over Saturday's readiness for the job.

But without the element of surprise, the emotional boost from a midseason coaching change or the return of Matt Ryan to the starting lineup, how can Indv (4-5-1) build on this momentum?

By following the same playbook Saturday employed last week - turning inward, ignoring outside noise and challenging the Colts to meet their own standards.

Linebacker Zaire Franklin saw Indy meet the challenge last week, and he's convinced it will continue to make a difference over the final seven games, too.

"It was really just a shift of a mindset and a refocus and, obviously, Jeff was the leader of that refocus," Franklin said. "It's just understanding this is our season, our team, our story and our chapter to write and we want to do our part to make sure we have a good story."

WHAT'S WORKING

Running game. For the first time since the season opener, league rushing champion Jonathan Taylor topped the 100-yard mark, scored a TD and ran effectively. Heck, even Ryan had a critical 39-yard run, a career long. Saturday knows this is the blueprint to success for Indy.

WHAT NEEDS HELP

Takeaways. One year after finishing second in the league in turnovers forced (33), Indy has struggled mightily. It has

nine takeaways through 10 games, and against the Raiders, for the third time this season, produced none. It's the one missing component from an otherwise impressive defense.

STOCK UP


Ryan. Just a few weeks after it seemed as if his long, illustrious NFL career might be over, the 37-year-old made a comeback. He was so impressive in practice that Saturday started him and Ryan delivered by going 21 of 28 for 222 yards, one TD and no turnovers for offensive line had its best game this the second time this season. If he keeps it up, Ryan could save Indy's season and extend his career.

STOCK DOWN

Sam Ehlinger. Two-plus weeks after being named the starting QB for the rest of this season and just days after Saturday said he'd keep Ehlinger in that role. the second-year quarterback from Texas was benched. If Ryan continues playing well, Ehlinger's next start may be a long way off.

The Colts lost DE Kwity Paye again due to an ankle injury. It's unclear
